



TERRY WHITE CHEMISTS REWARDSPLUS – ISOWHEY 8 WEEK CHALLENGE

HOW TO ENTER

To be eligible to enter the competition, individuals who are members of the Terry White Chemists RewardsPlus Program must present their Terry White Chemists RewardsPlus card at the point of sale when they purchase IsoWhey 8 WK Challenge Pack for \$79.95 at selected Terry White Chemists stores between 9.00am AEDST on 2nd March 2017 and 11:59pm AEDST on 26th April 2017. With each qualifying RewardsPlus purchase made between 9:00am AEDST on 2nd March 2017 and 11:59pm AEDST on 26th April 2017, the entrant will receive one (1) entry into the major prize draw to win a \$1000 gift card and one (1) entry into the minor midpoint draw to win 1 of 5 FitBit Charge 2 (valued at \$249.85 each). With each qualifying RewardsPlus purchase made between 12:00am AEDST on 29th March 2017 and 11:59pm AEDST on 26th April 2017, the entrant will receive one (1) entry into the major prize draw to win a \$1000 gift card.

Entrants who purchase additional IsoWhey products and swipe their RewardsPlus card will receive additional entries.

TERMS AND CONDITIONS

1. Any information on how to enter the competition and prizes received by the winners of the competition form part of these Terms and Conditions. Participation in the competition is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Australian residents only who are aged 18 years or older and who are members of Terry White Chemists RewardsPlus program. Employees (and their immediate families) of the Promoter, or of a Terry White Chemists store or other agencies or companies associated with this Promotion may be entered into the competition as a result of making qualifying purchases and presenting their RewardsPlus card but are ineligible to win the competition.
3. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's receipt number, identity, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
4. Entrants may enter into the prize draws multiple times during the competition time period subject to the following: (a) only one (1) entry permitted per qualifying transaction; and (b) each entry must comply with entry requirements specified in these Terms and Conditions.

Purchase receipt(s) must clearly specify the store of purchase and that the purchase was made during the promotional period.

Entrants who enter the competition between 9:00am AEDST on 2nd March 2017 and 11:59pm AEDST on 26th April 2017 will be entered into the draw to have the chance to win a \$1000 gift card as a major prize and 1 of 5 FitBit Charge 2 as a minor midpoint prize. Entrants who enter the competition between 12:00am AEDST on 29th March 2017 and 11:59pm AEDST on 26th April 2017 will be entered into the draw to have the chance to win a \$1000 gift card as a major prize but will not be eligible to win 1 of 5 FitBit Charge 2.

The Promoter's decision is final and no correspondence will be entered into.

11. The Promoter, in its sole discretion, reserves the right to substitute the prize (or part of the prize) with a prize to the equal value and/or specification, subject to any written directions from a regulatory authority.
